A BRIEF PROFILE OF KOMFO ANOKYE TEACHING HOSPITAL (KATH)

Komfo Anokye Teaching Hospital (KATH) situated in Kumasi is the second largest tertiary health institution in Ghana. Established in 1955 initially to serve the people of Kumasi but later was elevated to a Teaching Hospital to serve as the training institution of medical students from Kwame Nkrumah University of Science and Technology (KNUST) after the establishment of its school of Medical Sciences (SMS) in 1975. KATH over the decades has provided to millions of clients and periphery health facilities across a very wide spectrum of specialist health care. Thousands of medical professionals have received their pre-and postgraduate training for medicine, nursing, pharmacy and in other allied health disciplines. The Hospital runs its operations through a semi-decentralized thirteen (13) clinical directorates, two (2) non-clinical directorates and eighteen (18) units.

The hospital which has official bed capacity for 982 beds generally operates up to 1200 beds due to the ever-increasing number of patients in need of specialist services, in spite of the limited operational space. KATH is the second largest public tertiary health care facility in the country, and arguably, the tertiary health care facility and referral centre with the largest catchment area, stretching from the middle belt to the northern parts of Ghana and beyond.



VISION

The vision of KATH is to become a centre of excellence in the provision of specialist health care services.

MISSION

KATH's mission is to provide quality services that meet the needs and expectations of all our clients, achieving this through well-motivated and committed staff applying best practice and innovation.

MANDATE

Legally KATH's mandate in line with the Ghana Health Service and Teaching Hospital's Act, 1996 (Act 525) and the Ghana Health Service and Teaching Hospitals (Amended) Act, 2019 (Act 1009) is

- a) To provide advanced clinical health services to support the health services provided by the Ghana Health Service and the other service delivery agencies of the Ministry of Health;
- b) To serve as a training ground for undergraduate and post graduate training in the medical and other health professions; and
- c) To undertake research into health issues for the purpose of improving the condition of health of people in the country.

KATH undertakes its various diverse functions through a current total workforce of 5,385; consisting of 41.44% Nurses and Midwives, 14.53% Doctors, 2.01% Pharmacists/Pharmacy Technicians and the remaining 42.02% are Allied Health Staff, Finance & Administration and other Support staff

COVERAGE

Komfo Anokye Teaching Hospital (KATH) as a tertiary health care centre and specialist facility, which serves not only Ashanti region but also receives referrals from thirteen (13) out of the sixteen regions of the country, stretching from the middle belt to the entire northern sector of Ghana. KATH even sometimes, receives referrals from beyond the borders of Ghana, especially Cote d'Ivoire and Burkina Faso. The Average Daily Out-Patient-Department (OPD) attendance at KATH is 1,093 which translate into 32,790 per month or 393,480 per year. Average daily admission is 150 which add up to 3,100 per month or 37,200 per annum.

LEADERSHIP AND GOVERNANCE

Komfo Anokye Teaching Hospital (KATH) is overseen by a Governing Board in line with the Ghana Health Service and Teaching Hospital's Act, 1996 (Act 525) and the Ghana Health Service and Teaching Hospitals (Amended) Act, 2019 (Act 1009). However, the Day-to-day administration of the Hospital is by the Executive Management Team (Central Management), headed by the Chief Executive and supported by seven (7) functional Directors. The Executive Management Team or the Central Management implement policies and ensure day-to-day operations through fifteen (15) directorates and eighteen (18) units, each operating as a decentralized system under a management team (Directorate/Unit Management Team).

The corporate objectives which guides the actions of the Hospital are as follows:



Ambassador Nana Effah-Apenteng is a seasoned diplomat, a veteran traditional leader and an astute administrator of many years standing.

He holds a Bachelor of Arts, BA (Hons) Political Science and Masters of Arts, MA in African Studies from University of Ghana, Legon. He obtained a Diploma in Public Administration in 1974 and Certificate in Diplomacy in 1975 from the Ghana Institute of Management and Public Administration (GIMPA) and Oxford University, respectively.

Nana spent most of his working life at the Ministry of Foreign Affairs of Ghana. Nana was the Ambassador and Permanent Representative, Permanent Mission of Ghana to the United Nations, New York, from 2000–2007.

Nana is currently the Paramount Chief of Bompata Traditional Area and one of the five Paramount Chiefs representing the Ashanti Regional House of Chiefs at the National House of Chiefs of Ghana, where he is Chairman of the External Relations Committee. He is also the Deputy Chief of staff at the Otumfuo's Secretariat at Manhyia Palace, and a member of the Standing Committee of the Ashanti Regional House of Chiefs.

He worked as the Vice Dean /the Deputy Director Student Affairs (in charge of Student Conduct and Discipline) for four (4) years at the Kwame Nkrumah University of Science and Technology Kumasi, Ghana. Prof. Addai-Mensah has extensive experience in scientific research and general management and has a number of publications in reputable journals to his credit. His research interests are in Infectious Diseases, Malariology, Biomedical Sciences, Immuno-epidemiology, Haematology, Immunology, Transfusion Medicine and Public Health.

He is a trained medical doctor, and holds a BSc in Human Biology and an MBChB from the School of Medical Sciences of the Kwame Nkrumah University of Science and Technology (KNUST), an MSc. in Biomedical Sciences from the University of Westminster in London-UK, and a PhD. in Immunology and Biotechnology from the prestigious RWTH University in Aachen, Germany. 



CONCEPT PAPER

BACKGROUND

The Komfo Anokye Teaching Hospital is the second largest teaching hospital in Ghana. The hospital has the following mandate:To provide Tertiary Service (Specialist Clinical care)

- To train graduate and post graduate medical students and other health professionals.
- To conduct research; and
- To support primary and secondary healthcare services.

This mandate is achieved through the effort of all cadre of staff who have received training in their various fields locally and internationally.

The pivotal role played by the Senior Specialists and Consultants in the delivery of this mandate cannot be overemphasized.

Over the years there has not been any structured platform for regular engagement between central management and the consultants and Senior specialists to take stock of the hospital's performance, brainstorm and develop consensus on increasing efficiency and job satisfaction in health care delivery. This undoubtedly limits KATH from fully utilizing its available highly trained, experienced and knowledgeable human resources, a development which will eventually have negative impact on services, teaching and research.

To help engender greater involvement of key stakeholders in the hospitals governance system and practices, enhance operational capacity and deepen its institutional responsiveness and resilience in the provision of customer-centric specialist care to the public, a consultative forum has been instituted by the office of the Chief Executive to ensure continuous engagement with Senior. Specialist and Consultants of the Hospital.

In response to the above need, following consultations with a number of actors in the hospital, the consultative forum will afford Senior. Specialist and Consultants, the opportunity to bring to bear their views on how health care delivery, training and research in KATH can be improved. The Forum, to be convened annually, will facilitate the process of consensus building towards a shared vision of quality health care delivery at KATH and the strategies and mechanisms for realizing that vision.

OBJECTIVES

- The overall objective is to facilitate a process of consensus building among the key stakeholders
 of KATH Board, management, Senior specialist and Consultants. We expect some 150 to 170
 invited participants at the forum each year, which will be a clearinghouse of ideas towards the
 achievement of a shared goal and priorities for the hospital.
- Another objective of the Forum is to create a mechanism and process for bringing together the
 most important actors in the provision of health care delivery in the hospital to brainstorm on
 the state of health care delivery
- Create a platform for acknowledgement of the invaluable insights and expertise of Senior specialist and consultants in the provision of quality tertiary healthcare, training and research

IMPLEMENTING THE FORUM'S PROGRAMS

The Forum will convene yearly and:

- Focus on one selected theme—to be chosen through the consultative mechanism with the Board and Management of the hospital
- Discuss issues affecting health care delivery and strategies to address them
- Draw up a time-bound action plans to implement recommendations from the forum and also institute monitoring mechanisms to ensure successful implementation.



The underlying preparatory work will be undertaken and/or guided by the Forum's Committee comprising office of the Director of Administration, Medical Director, Planning Monitoring and Evaluation, Finance, Public Affairs, Human Resource Management and representatives of Senior Specialists and Consultants group. The Committee may co-opt additional experts in its work depending on the theme of the forum and the task at hand.

The first Consultative forum will take place on 20th July, 2023 at the Golden Bean hotel in Kumasi on the theme: *Driving a customer-centric Health care Delivery at KATH: The role of Senior Specialist and Consultants.*

SUMMARY OF THE FORUM'S BROAD ACTIVITIES

The Forum's activities will be organized around the following components:

- There shall be presentations from experts on topics that are relevant and currently affect the operations of the hospital
- There will also be a panel discussion on the state of health care delivery with panel members drawn from the medical, surgical, and diagnostics disciplines
- There will be a plenary session for members to also bring on board their views on health care delivery at KATH.
- The forum will be financed by KATH and other stakeholders that provide services to the
 hospital, such as pharmaceutical companies and other companies the hospital deals with
 in the acquisition of its various supplies. In view of this, sponsorship letters have been sent to
 pharmaceutical companies to sponsor the maiden edition of the programme.

OUTCOMES OF THE FORUM PROCESS

- The Forum is expected to enhance consensus on the direction and priorities of the hospital in delivering health care to the people of Ghana
- The forum aims to deepen consultations, promote team work and engender greater integrations
 of systems for efficient service delivery
- The forum is expected to solicit for ideas from health care providers on the way forward in delivering modern health care to its clients
- The Forum will come out with mitigation measures that will help address key issues that affect post graduate medical training at KATH
- The forum is expected to create an enabling environment towards a research driven service delivery at KATH
